- Printing 30,000 flyers (A4) colored.

If payment is executed in US Dollar (USD), it is the Bidder's responsibility to own a bank account in US Dollar (USD) <u>registered in the name of the company</u> and be authorized to receive electronic transfer (EFT) in US Dollar (USD).
